



## Booking Terms and Conditions

**PLEASE SIGN AND RETURN A COPY.**

**Here at Blush Brides we like to ensure we give the best possible customer service. We believe that a component of this, relies on both ourselves and the bride clearly understanding what our service involves and how we operate. Please read the following terms and conditions. Congratulations on becoming a Blush Bride!**

### **BOOKINGS/PAYMENTS**

A non-refundable deposit of the specified amount must be received before your date is secured in our diary. This payment will secure your wedding date and stylists. A 3 day cooling off period applies once your deposit has been received.

Your balance is due 14 days prior to your wedding date. Payments can be made in cash, cheque, money order, credit card over the phone, or direct Internet banking transfer. We reserve the right to cancel your booking and keep your deposit if full payment is not received within the 14 days or prior.

By Paying your deposit to Blush Brides you are agreeing to our terms and conditions. Please scan and email or post a signed copy back to us.

Blush Brides requires a minimum payment  
\$560 when booking both hair and makeup  
\$270 makeup only  
\$290 hair only

Blush Brides requires a minimum of 3 adults booking our services. If you do not have 3 people we are of course still happy to take your booking however there will be the cost of 3 charged. The reason for this is so that we can continue to provide a mobile service to our brides. Traveling time and petrol costs associate with being a mobile business have been considered in our pricing.

No payments are to be made to our stylists on the day of the wedding. Any additional people deciding to be pampered by Blush Brides will need to be paid for with credit card over the phone or via direct internet banking after the wedding. please notify us immediately.

### **PRE WEDDING TRIALS**

Blush Brides recommends that you have a trial 4-6 weeks prior to your wedding date. This ensures you will be completely satisfied on your wedding day.

This is to ensure maximum satisfaction you and your Blush Brides Stylists. The pre wedding trial is designed to discover any potential issues that you may have with any products, staff, or services you may have provided by Blush Brides before the event date.

If you choose not to participate in a pre wedding trial,

We will not be held responsible or liable in ANY way if you are dissatisfied with any part of our service on or after the event date. Our satisfaction guarantee will no longer apply.

Blush Brides is a mobile service and unless we are able to hold your trial in our Nelson Bay studio, you are expected to provided a location for your trial to take place. eg. - Your home or hotel room in the area in which your wedding day will be.

Your trial must take place in the region of your wedding as this will be where your stylist are from. Travel fees apply to go outside these regions.

### **NEWCASTLE, HUNTER, PORT STEPHENS WEDDINGS :**

From October 09 your trial will be held in our gorgeous Nelson Bay Makeup Studio. Trials will be held on the last Sunday of each month and we will notify you of your trial date once booked.

Trials will be \$80 each, paid in cash on the day. You will receive a class of sparkling champagne at your appointment.

### **SYDNEY, CENTRAL COAST, BLUE MOUNTAINS, MACARTHUR, HILLS DISTRICT AND SURROUNDING AREAS :**

Your trials are currently done in the comfort of your own home/hotel at a time that suits yourself and your stylists.

### **ON THE TRIAL DAY**

Please come to your trial with some idea of the general look/ style that you would like to achieve. With this in mind, you hair and make up artists will work with you to create Stunning hair and makeup, perfectly suited to you. Please allow approx 1 hour for hair trials and 1 hour for make up trials.

At trials, we expect our brides to be completely honest. If you are at all unhappy with the outcome or the direction of your trial, please advise us immediately. This way we can make alterations to provide a look that you are 100% happy with.

If you have had a trial and are unhappy with the final result, a second trial will be provided FREE of charge with another artist.

A before and after photograph will be taken and attached to your booking form. All details of your trial including hair notes make up colours and brands will also be recorded on your booking form.

Realistic expectations - Your stylist will consider your hair type, length, colour, condition, facial structure, skin type, skin tone, style and personality. Our extensive training and



experience allows Blush Brides to offer honest, professional beauty suggestions that emphasize your best beauty features and create a look that will suit you.

While magazine clippings, celebrity examples and various photographs may be used as a guideline for your desired look, it is important to recognize replications may not be suitable or possible to achieve.

**PLEASE NOTE** - We always do our very best to arrange for you to have both your hair and makeup trial on the same day. There are times when this may not always be possible due to our teams hectic schedule.

We are a mobile service and do not have our own studio. Brides need to provide a location for your trial to take place. Either your home or hotel room.

### ON YOUR WEDDING DAY

We will make every effort, to ensure that you have the same Hair/makeup artists that you had for your trial.

In the rare event, due to unforeseen circumstances, this is not possible, you will be notified and another artist will be supplied.

Every effort will be made to achieve the same look for you. We will even offer you a FREE trial if time permits. We ask that you and your bridal party are ready to commence on time. This involves having clean skin and hair.

Hair should be washed the night before and minimal conditioner applied.

If you are running late and will not be ready at the agreed time, please phone and advise us immediately.

### IMAGE RELEASE

Here at Blush Brides we like to show off our gorgeous brides. We will contact your photographer after your wedding, and arrange to be sent a few of your images to add to our website or use for advertising purposes. Blush

Brides reserves the right to use these professional images, along with any of our own images taken on the wedding or trial day.

### LIABILITY

Blush Brides acknowledges that we take the utmost care in providing clean and safe working conditions and procedures with regards to hairstyling and makeup application.

However Blush Brides will not be liable for any loss suffered in the event of skin breakouts/reactions or any other resulting injury from make up application / hairstyling.

We only provide fully qualified professional artists using high quality products and tools, and every care is taken to ensure absolute minimal risk. A trial is recommended 4-6 weeks prior to the wedding.

### CANCELLATION POLICY AND GUARANTEE

If you are unhappy with your trial or stylist, Blush Brides will provide a second trial FREE of charge. This applies only if you state that you are unhappy at the TIME. All makeup must be washed off and hair brushed out prior to leaving your appointment. If you are still unhappy after your second trial, we will refund any deposits paid in full, No hard Feelings!

Once your deposit is paid and your booking form filled in, we can not lessen the amount of people booked in for our services. You may however, add people in who decide to get pampered on the wedding day also. This includes friends and family.
